

Vectren Indiana Residential New Construction Program

Refer to the information below to ensure you are eligible for Vectren's Indiana Residential New Construction Program. For the purposes of these terms and conditions, "Vectren" shall refer to Vectren Energy Delivery of Indiana, Inc. and/or its third-party implementer, CLEARResult Consulting Inc.

Rebate Offer

This program provides rebates for the construction of energy-efficient homes based on the Home Energy Rating System (HERS). The rebates on this application are available to single-family detached homes, duplexes and end-unit homes in attached townhouses where only one wall is shared. One application must be completed for each address for which a rebate is requested. HERS certification must be completed between January 1, 2020 and December 31, 2020. All applications must be postmarked within 90 days of the HERS certification. Vectren reserves the right to alter or discontinue the rebate offers at any time without notice. Rebate funds are limited and are available on a first-come, first-served basis.

General Eligibility

All builders must complete a W-9 to receive a rebate. Ground source heat pumps as well as dual-fuel systems, where a heat pump is used in conjunction with a gas furnace, are not eligible for rebates. Rebates will only be paid to one person or entity. New Construction Rebate recipients cannot apply for equipment rebates through the residential rebate program if they are receiving a rebate through the residential new construction program. Homes must use Vectren natural gas and/or electric service (central electric air conditioning must also be present for electric customers) or electric service where an electric heating system is the main source for space conditioning.

HERS Rating Eligibility

HERS ratings must be completed by a RESNET® certified HERS Rater between January 1, 2020 and December 31, 2020. The home must meet the HERS Index Score requirement for Gold Star, Platinum Star or Platinum Plus to qualify for a rebate.

Compliance

All projects must comply with applicable federal, state and local laws and regulations, including building codes, and manufacturers' specifications.

Application Delivery

A complete, signed application and HERS certification must be submitted to the address located on the cover page of this application within 90 days of HERS certification. Vectren is not responsible for items lost or damaged in the mail. Vectren will pay only one rebate for each eligible home. Please allow up to six weeks to receive your rebate. Incomplete applications cannot be processed. Failure to provide supporting documentation will be considered an incomplete application. Please keep a copy of your application and supporting documentation for your records.

Governing Law/Jurisdiction

This Agreement shall be governed by the laws of the State of Indiana. Any disputes arising out of or related to these Terms & Conditions shall be resolved in Vanderburgh County.

Verification

Vectren reserves the right to verify HERS certificates before issuing rebates. All homes are subject to verification by the program to ensure the project meets program requirements. Making false statements on any Vectren rebate application is punishable by law. Any and all funds determined, in Vectren's sole discretion, to have been acquired on the basis of fraudulent or misrepresented information must be returned to Vectren. Vectren reserves the right to refuse payment and participation if the signatory(ies), applicant(s), customer(s), or contractor(s) violate program rules or procedures.

Tax Information

Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for contacting a qualified tax advisor to determine tax liability. Vectren is not responsible for any tax liability imposed on the customer as a result of the payment of incentives.

Customer Information
