Eligibility requirements

A home must be rated by a RESNET® certified HERS Rater between January 1, 2020 and December 31, 2020.

- Homes constructed in Vectren natural gas and/or electric service territories are eligible for rebates.
- Service must be active at the time of application submittal.
- Rebates are available for single-family detached homes, duplexes and end-unit homes in attached townhomes, where only one wall is shared.
- Ground-source heat pumps and dual-fuel systems, where a heat pump is used in conjunction with a gas furnace, are not eligible.
