HOW TO APPLY FOR A REBATE

Step 1:

Sign up as a Participating Builder

Builder Information

Builders only have to complete the Builder Participation Form one time. The form will remain on file for the entire program year.

Builders must submit a completed W-9 form prior to requesting rebates.

Step 2: Build an Energy-Efficient Home

Additional Documentation

If the home was HERS rated include the HERS certificate. If the home was not HERS rated, please include the invoice containing the rebated items being applied for.

Active Service

The property must be serviced by CenterPoint Energy Delivery of Indiana, Inc. ("CenterPoint Energy") under an active residential account.

Step 3:

Submit Part 2 Paperwork/ Digital Smartsheet

When you've finished a project, send us the home info and a copy of the HERS certificate or invoice.

Submit Application

Submit the completed application and a copy of the HERS certificate within 90 calendar days of certification or sale of home in one of the following ways:
